Where composite rate is agreed instead of item wise rate, there Supplier shall strictly maintain the supply of material as per below % ratio of aggregate. Said ratio shall be maintained during each billing cycle & payment will be processed based on the ratio only.-

- 2. Source of Material:-Material to be supplied at Camp from Approved mines & quarries # as mentioned HGIEL team may visit the production site randomly for assessment of source.
- 3. Transportation: -Thetransportation is inclusive in above mentioned rate.
- 4. Supply period :-
- 5. Mining Royalty & other taxes:-The current rate is inclusive of mining royalty & other applicable taxes, environmental tax, but exclusive of GST. If supplier do not supply royalty paid material then applicable amount with interest and penalty will be recovered from payable to supplier.
- 6. Quality & Inspection: Materials being supplied by you shall be subject to inspection by our Engineer in charge and QA/QC in charge at project site. Further conformity to specification shall be tested regularly by HGIEL site laboratory as well as by way of 3rd party tests if so required by HGIEL.

In case of not meeting any requirement during inspection you shall take back the entire load. No payment/detention charge will be paid for rejected materials. Replacement for the rejected quantity as instructed by project manager shall be done within 24 hours.

- 7. Supply Program : As per site requirement. Supplier has to supply 80 to 120% quantity of ordered quantity every month & at the end of 3 months, 90 to 110% of ordered quantity. If Supplier fails to supply in the same limit, then HGIEL shall be at liberty to make all alternate arrangements & extra cost incurred by us shall be debited to Supplier.
- 8. Prices : Above rates are applicable only for supply under UNDERLOAD condition eg. 22 Tyre Semi Trailer Gross Weight(GVW) is 55 MT & 12 Tyre single chassis rigid truck Gross weight(GVW) is 36 MT with Weight tolerance up to 5% in the gross vehicle weight(GVW) and any supply of listed item beyond this shall be considered at previous purchases order rate issued by HGIEL Prior to 20-Nov-2020.

Above rates are applicable only for supply under UNDERLOAD condition purely VIA Road.

As the same (under load condition) may not apply on supply via rail & then by road.

- 9. Price escalation: The Unit rates in the purchases order shall remain fixed & firm throughout the supply period mentioned above or any extended period thereof without variation for whatever intents & purposes till completion of supply.
- 10. Change in law: -Any increase/decrease in Royalty/taxes shall be adjusted accordingly.
- 11. Rejection :-If any materials found rejected by QC/Lab Dept./HGIEL representative after unloading then the cost of rejected material will not be considered for payment.
- Billing Schedule :-Supplier shall submit invoice fortnightly/monthly.
- Loading & Unloading :-Loading/ unloading is in SUPPLIER's Scope.
- 14. Payment Terms :-HGIEL would ensure to disburse the payment within 45 days from the date of submission of invoice.
- Advance Payment :-Not Applicable.
- 16. Retention :-Not Applicable
- 17. Facility from HGIEL:-If any material (excluding HSD) issued by HGIEL, which is not covered under this contract shall be recovered by raising separate bill @ actual landed cost plus (+) 10% handling charges plus (+) taxes applicable.
- 18. Weight :-The quantity will be measured at HGIEL own weigh bridge and the Weighmentshall be final and binding on both the parties. Supplier shall be responsible to collect the receipt of material with HGIEL weigh slip. If any of the parties is not satisfied with weight than can designate representative for joint verification at two external weigh bridge to clear the doubts. The joint measurement shall only be considered for purpose of billing if required. The weigh bridge of supplier also shall be calibrated by third party by quarterly in presence of our representative and necessary calibration certificate shall be produced for our record. However, a random

checking for Weighment shall be taken up by the site team for ensuring the correctness of the measured weight at another identified weigh bridge.

- 19. Performance Guarantee :-Applicable (Specify terms and recovery).
- 20. Pre Dispatch Inspection:-(Applicable) HGIEL duly authorized and designated inspection engineer will inspect the material before the dispatch at SUPPLIER#Swarehouse/ Stock yard(As & when required) and at delivered location. This however does not absolve the responsibility of the SUPPLIER regarding quality/performance and guarantee of the materials.
- 21. Permission and License :-Unless otherwise specifically agreed, All Mining & pollution Control board permissions shall be arrangedby SUPPLIER. If required, Explosive magazine permission for carrying out blasting work, NOC for crusher operation or any other statutory permission required for production/ crushing operation shall be in the scope of supplier and valid documents must be produced to HGIEL.
- 22. Overloading material: -HGIEL in no way shall be responsible and does not authorize any overloading or carrying of goods beyond the permissible weight.
